### Real Life Clients!

Usually when I teach this course, I am using hypotheticals or several groups are working on different projects. I'm really excited to report that our workshop will have a pair of real live clients! That is, two co-founders are joining us to work on their own contract and we're going to use their process as a learning opportunity. Lawyers in the group will be given the opportunity to work directly with the co-founders on segments of their process and document. This is a jump start on certification, for those interested in taking this beyond a course.

### Format & Content

The format of each class will be that the first part of the session will be focused on reviewing the last assignment, then new content, ideas, tools, and skills. The remainder of the session will be spent on applying those topics experientially. For example, in one session we will talk about the importance of values, how values are being used in contracts, and then we will work on creating a touchstone statement of our own values.

I've scheduled us for two hours and expect most sessions will come close to that. In small groups, sometimes the timing works out differently. I don't need to hold you longer than necessary to cover the materials. If we get finished, we'll end early.

### Recording

I can record the content portion of the course but not the experiential part. Since this process requires a paradigm shift, the experiential segments are important. If you are going to miss a session, please make arrangements to practice with someone before our next session. (Really, it is going to be easier if you just show up.)

### CLE/CPD

Our group is from around the world and our participants represent different professions as well as different geographic locations. It is not practical to apply for continuing ed credits in so many different circumstances. It has been my experience that most accrediting bodies will retroactively give points to eligible courses.
